Help patients save on their prescription

How to process the Complete Savings Card:

- ✓ **Submit the claim to the primary third-party payer first**
- ✓ If you receive an **approval** from the primary payer, then submit the Savings Card as COB with **OCC 08**
- ✓ If you receive a **rejection** from the primary payer due to a prior authorization, National Drug Code (NDC) Block, or product not covered, then submit the Savings Card as COB with **OCC 03**
- ✓ For processing and rejection questions, please call **1-800-761-5285**

In the event of a rejection from the primary payer, it is important to inform the prescriber's office to pursue coverage.
